



# **CONDITIONS OF PARTICIPATION**

# Berlin, September 05, 2022

The Berlin Newcomer Startup Award 2022 is an initiative of SINGA Deutschland gUG (the organizers), funded by Senatsverwaltung für Wirtschaft, Energie und Betriebe - Landesstelle für Entwicklungszusammenarbeit (the funders) supporting newcomer entrepreneurs in real- izing their business ideas and celebrate their creativity, talents and potentials.

## WHAT ARE THE PRIZES?

The winners of the Berlin Newcomer Startup Award will be granted a combination of prize money

to realize their business idea and a fixed budget to be spent on coach- ing and consulting.

- 1st prize: 10.000€ seed capital + 2.500€ budget for coaching / consulting
- 2nd price: 7.500€ seed capital + 2.500€ budget for coaching / consulting
- 3rd prize: 5.000€ seed capital + 2.500€ budget for coaching / consulting
- winner public voting: 5.000€ seed capital + 2.500€ budget for coaching / consulting

Winners have to accept the prizes in full and sign a "De Minimis declaration". If you don't know what a De Minimis declaration is: Don't worry, then you're safe!

# WHO CAN APPLY FOR THE AWARD?

We are searching for (future) newcomer entrepreneurs who:

- are at least 18 years old, live in Berlin and have moved to Germany within the last 8 years, i.e. in 2014 or later.
- have the nationality of one of the countries from the DAC List of ODA Recipients.
- are planning to create their business or are just in the founding phase but didn't enter the market yet!
- apply as individuals or with a team of co-creators / co-founders.
- speak English, as the program language is English.

The organizers reserve the right to exclude applications that do not meet the conditions of participation from the competition.







# HOW TO APPLY FOR THE AWARD?

The application period for the Berlin Newcomer Startup Award begins on September 05, 2022

and ends on October 5, 2022.

Applications will only be accepted if submitted via the application form on the organizer's website

and are not complete until the applicants have also submitted their pitch video via Wetransfer to

sbl@singa-deutschland.de as stated in the application process.

All complete applications received by the end of October 05 2022, meeting the requirements will be considered in the selection process.

# HOW WILL THE WINNERS BE SELECTED?

The degree of fulfilment of the conditions of participation will be assessed by the organizers after submission of the application.

The organizers reserve the right to reject applications that do not meet the conditions of participation.

An expert jury assigned by the organizers will evaluate all valid applications and select six finalists until October 19 2022.

Preselection meetings will not be public nor will be their evaluations. All applicants will be informed about their nomination or rejection by email. Please note, that because of organizational reasons you will not get detailed feedback on why the jury nominated / did not nominate them.

The six finalists compete in a public voting on the organizer's website. More information on and rules of competition for the public voting will be published there as well. The winner of the public voting will be announced during the award live show on **November 03 2022**.

The six finalists also commit to **pitch their idea** at the award live show. The expert jury will evaluate the presentations and decide on the winner of the **3 main prizes**.

Pitches will be evaluated on the following criteria:

Degree of Innovation of Product or Service Solution

 $\cdot$  Clear understanding and attractiveness for target market/group  $\cdot$  Competition on the market

- Feasibility
- Business attractiveness
- Team (if any) and network
- Entrepreneurial responsibility
